## NOTICE TO EXHIBITORS

**All entries for all events will be ONLINE SUBMISSIONS VIA JOTFORM and must be received on or before final due date of Feb 13, 2026**

**Entry fees shall not be refunded** in the event that a dog is disqualified, excused, or barred from competition. If, because of riots, civil disturbances

or other acts beyond the control of the management, it is impossible to complete the shows, no refund of entry fee will be made.

**Returned checks** do not constitute a valid entry fee. The IWC will add a \$25.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.

**Please note that a photographer(s)** may be present at this event and will be taking photos and video of dogs, exhibitors, and spectators that may be posted on social media.

**Errors on entry blanks.** Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in the event of such errors.

Time of judging is printed in this Premium List. No further Judging schedule will be mailed. No Judging Program will be mailed for this event.

**Dogs need only be present** for scheduled judging and will be released if not needed for further judging. IWC will not be responsible or obligated to furnish any service through a public-address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**Judges need not wait** for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.

**All dogs present** must be held on leash or confined to their crates except when being judged.

**IWC will use due care** and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors, or their families participating in this show, and further assumes no responsibility for injury to children.
